In accordance with Listing Rule 3.1, I attach an updated Appendix 3B which notes that:

- 1 the option held by Corporate Governance Australia Pty Ltd (“CGA”) over 937,500 unissued ordinary shares expired on 31 December 2010;
- 2 the only options which remain on issue are:
  - (a) an option held by CGA over 3,750,000 unissued ordinary shares.
